

DMA Marching Band and Color Guard Contract

- All members must attend summer Band Camp.
- All members are required to attend all rehearsals, performances and competitions.
- **Sneakers** are required for after school rehearsals, violation will count as “missing practice” unexcused.
- Marching Band Dues: Members are required to pay dues of \$200.00 which is used to supply transportation, maintain and purchase new equipment as needed.
 - \$40 Equipment fee: Added to the dues if a cadet is **Guard member, percussionist** or is **renting** a DMA instrument for the season to help counter the cost of repairs and upkeep.
 - Dues should be paid in full by Sept 6th, 2019 and will accrue a late fee of \$25.00 the starting Sept 30th and a \$5.00 fee each month thereafter.
 - PayPal is an option on the SeahawksMusic.com web page but includes a \$6 processing fee.
 - We will still accept checks as well and payment can be made at the Band Camp Picnic.
- Absence Policy:
 - To request that your absence be excused, Mr. Grant should receive a note as soon as possible or at least 7 days prior to the absence.
 - If a Cadet is ill and is going to miss a performance contact Mr. Grant immediately and a note should be presented when the Cadet returns.
 - Work and other outside curricular activities are not considered excused absence.
 - Doctor appointments should be scheduled around the performance and rehearsal schedule if possible. If absolutely unavoidable request and excused absence as noted above.
 - Penalties for unexcused absences: 1 miss = warning, 2-4 misses = I don't march that game weekend/competition (but must attend the game/competition), 5 misses = Removal from the show.
- Cadets are required to observe **all** school rules when they are at any bandfunction.
- Cadets are required to remain in uniform at events.
- Family and Friends are not permitted to sit with the band cadets in the stands at football games.
- Cadets are not permitted displays of affection anytime they are in uniform.
- Cadets are only permitted to have water, not food, in the stands during the football game.
- Driving Policy: If a Cadet intends on **driving** or **riding** to or from an event with another cadet, those cadets should provide the transportation permission slip with confirmation of both parental parties.
- Bus Policy: When given the option, Cadets are required to fill out an online form before the event as to their bus status; whether they will be riding the bus to the event or home from the event as to provide an accurate account of those traveling with the group.
- Media Policy: This contract allows cadets to be photographed and videoed for promotional and instructional purposes. We also hope to preserve your child's amazing experience so that it can be shared by family and friends for years to come! 😊
- Most Importantly: Cadets will come to practice with a positive attitude and ready to work.
